## **G1275 SYSTEM WARRANTY**

### PRODUCT WARRANTY CONDITIONS

This Product Warranty does not cover any Product defects or damage to the extent it is caused or contributed to by the following:

- 1. Modification of the Product without prior written approval from Vent Systems; or
- 2. Application or attachment of the Product to another material or substrate using adhesives or other fixing methods prior to be affixed to the building structure; or
- 3. Prior to or during installation, damage caused to the Product as a result of incorrect handling and/or incorrect onsite storage, high winds or vandalism please refer to Roof Ventilation Products and Cavity Battens documentation for correct storage and handling; or
- 4. Damage caused to the Product as a result of cleaning with a high pressure water cleaner, high pressure media cleaner, mechanical/abrasive cleaning device or chemical agents; or
- The Product is exposed to corrosive in-situ conditions, such as a poorly vented alkaline or acidic environment, ceiling space with an un-flued gas heater or other enclosed space that does not provide adequate air quality to prevent deterioration of the Product; or
- 6. The Product is used in a harsh environment without prior written consultation and approval from Vent Systems, including livestock buildings and fertilizer storage facilities or as outlined in the literature supplied by Vent Systems; or
- 7. Where timber treatments have been used and the Product has been exposed to this timber before the treated timber has fully dried; or
- 8. The Product is used outside its intended purpose as outlined in the literature supplied by Vent Systems; or
- 9. The Product has not been covered as soon as possible, and was left exposed to UV for longer than 30 day

The warranties above are provided in addition to other rights and remedies available in respect of the acquisition of products by a "consumer" (as defined in the Competition and Consumer Act 2010 (Cth)). The following statement is provided where Vent Systems has provided products to a buyer who is a "consumer" under the Australian Consumer Law:

Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.
